- Current and next year's projection of attendance, income and expenses (include the operating expenses of proposed new facility if applicable)
- Proposed project plans, including fixed price building contract, quotations, timelines etc.
- Church Council meeting minutes recording project approval
- Profile of congregation and Church Council members (names, experience, time in position etc.)
- Attach comments and/or recommendations from your presbytery and the Property Services.
